ORDER

OPEN FORUM

The owners of 1858 Parkwood Drive attended the meeting to discuss the replacement of a fence on their property. It was noted during discussion that the owners had replaced the fence with a new style without the prior approval of the Architectural Committee. The Board agreed that the new fence was acceptable with the association's architectural standards but the homeowner was reminded that all future exterior modifications must be reviewed by the committee prior to the work being performed.

Landscape Committee – Miles Dooher reported on the following:

- Weedy lawns The Committee will inspect homes to make sure the front yard weeds are being cut regularly
 where the owners choose not to water the lawn and let them grow.
- Phase 4 tree pruning Completed by Advanced Tree Care, during the project it was noted that an additional Buckeye and Alder were removed by ATC at the Committee's request.
- Irrigation improvements Completed by Jim Cozzolino
- Oak tree pruning on Parkwood It was noted that there are Oak trees along Parkwood Drive which appear to need pruning in order for the City's street sweepers to clear the gutter at the curb. Advanced Tree Care submitted a bid to prune the 24 trees, but after some discussion it was agreed to have Bob Kiss and Robert Kozak review the area before a decision is made to perform the work.

- Annual weed abatement (fire safety) completed by Cozzolino. A reimbursement letter will be submitted to the City for their portion of the abatement
- 1805 Parkwood Homeowner removed dead tree on property with City approval.
- 3400 Chris Lane met with homeowner regarding issues with a hedge the owner wants to trim behind their property. Landscape Committee provided verbal approval to the homeowner to trim the hedge at the owner's cost.
- 3400 Westwood Court The owner requested and received permission for Advanced Tree Care to prune association trees behind their home at the owner's cost.
- 1485 Cherrywood After inspection by Advanced Tree Care, the Committee agreed to have ATC remove dead and broken branches behind 1485 Cherrywood.
