^{*}Quorum is the number of eligible voters needed to conduct the election

^{**}Ballots are **voided or invalid** when (i) outer envelopes are not signed, (ii) ballots contain more total votes than permitted for Board of Director positions (three in this case), or (iii) non-official ballots are substituted for those mailed to voters.

^{***}Abstentions occur when voters (i) cast ballots that are not voted, i.e., a voting section of the ballot is blank, or (i) the voter selects "Abstention" when it is provided as an option, such as for the Tax Resolution. Abstentions are counted toward quorum.
