Board Treasurer, Robina Ramm was absent. It was reported that the 2022 taxes have been completed and signed. Board President, Bob Kiss, noted that the Association is under budget for the current fiscal year in operating and reserves.

PML sent out a courtesy letter to those homes whose 2022 dues have still not been paid. One homeowner requested to have their late fee of \$80.00 waived. After some discussion the Board noted that they do not waive late fees without extenuating circumstances, and that although the dues are due on January 1st late and late after February 15, fees are not applied until April. This gives homeowners plenty of time to avoid the late fee.

Landscape Committee -

Proposals from Loral Tree Care as follows:

- Removal of dead trees near 3421 Westwood and 1467 Cherrywood for \$15,600.00
 Additional tree removal between Chris Court and 1491 Cherrywood for \$4,968.00
- It was noted that the Board is meeting with Arborwell and Davey Tree to get additional proposals for this large tree work.
- It was requested that PML get a proposal from Tree Management Experts to inspect all the trees in our arborist inventory and prepare an updated 5-year tree care plan.
- It was requested that PML generate and send out a RFP for the 2022 large tree maintenance work from the current 5-year tree care plan.
- Concern regarding a large Oak Tree near 1858 Parkwood that is damaging the concrete.
 The concern is the tree is located near a retaining wall and could eventually lead to damage to that wall. The Landscape Committee and Board will take a look at this tree.
- 3513 Broadview tree numbers 47 and 48 are on the list to be trimmed this year as part of the 2022 plan. This information in response to inquiry from homeowner.
