We are still negotiating a long-term agreement with the city for cost-sharing each year, but wanted to communicate to you our success in receiving 2009 funds. Many thanks to our Landscape Chair, Miles Dooher, for leading the charge on this effort.

# ARCHITECTURAL COMMITTEE

Thanks to those owners who have addressed their 2009 external audit findings (about 50% of contacted owners have responded). If you have questions about audit findings regarding your property, please don't hesitate to contact the committee or PML.

Please note that garage door color is an integral element of the home's color scheme. When replacing garage doors, an architectural project form must be submitted for approval. This will ensure that the proper door color is being provided. New doors often need to be painted to match the house color scheme. The rules for garage door coloration are available on our website, or contact the committee (www.sugarloafhoa.org/architectural.html).

#### LANDSCAPE

In November, the maintenance crew, in addition to their regular work:

- Finished spreading wood chips at Parkwood Circle. The remaining chips will be spread at lower De Anza in common areas off the sidewalks under the Oak trees.
- Trimmed Pear tree branches hanging over fence in common area behind Leafwood.

Planned for December, in addition to regular work:

- Monitor drain swales for any debris build up.
- Finish trimming of plant material at Westwood-Allison.

Our Sugarloaf sign at Parkwood and De Anza is in need of structure repair due to dry rot. The Committee is in the process of getting bids for the job.

#### **VISITOR PARKING**

Please be reminded that, per Section 5.04 of our Declaration, all parking spaces (other than home driveways) on our private lanes are designated as guest parking. Owners or tenants shall not park in these spaces on a regular basis, including consistent overnight parking.

#### PUBLIC SAFETY

Holiday Season is upon us. If you'll be installing holiday lighting, please review the following safety tips, courtesy of the Consumer Safety Products Commission (http://firstaid.about.com/od/injuriesathome/qt/06\_xma slights.htm)

- Choose lights that have been tested and deemed safe by a reputable testing laboratory, the best are UL or ETL. Lights listed as safe by these laboratories will note that on the packaging.
- Try to use the cooler-burning "mini" lights as opposed to the traditional larger bulbs. The older style burns much hotter.
- Only use lights that have fuses in the plugs.
- Inspect each set of lights old or new for damage. Return or throw out any set with cracked or broken sockets, frayed or bare wires, or loose connections.
- Replace burned out bulbs promptly with bulbs of the same wattage.
- Never hang lights on a metal tree. The tree can become charged with electricity and shock someone. The tree can also short out the lights and cause a fire.
- For outdoors use, make sure to use outdoor lights. The packaging will note whether the lights can be used indoors, outdoors, or both.
- All outdoor electrical decorations should be plugged into a ground-fault circuit interrupter (GFCI). You can buy portable units for outdoor use, or you can have them permanently installed by an electrician.
- Use extension cords properly. Outdoor cords can be used inside or outside. Do not overload extension cords - they can get hot enough to burn.
- Secure outside lights with insulated holders (never use tacks or nails) or run strings of lights through hooks.
- When you leave or go to bed at night, turn off your holiday lights.
- Never pull on a string of lights, it stresses the cords and can lead to fraying. Store lights loosely wrapped for the same reason.
