ARCHITECTURAL COMMITTEE

Thanks to all for the lovely holiday lighting. As in past years, the Board asks that you remove holiday lighting no later than February. Thanks for you cooperation.

If you're replacing your roof, you will need to submit a project application and receive approval to proceed, including notification of your neighbors. If you're performing more minor work, such as a roof repair, or any other project which will have workers on your roof, please take the time to notify your neighbors of the project. Often, your worker will need to spend some time on your neighbor's roof to complete your project!

LANDSCAPE

In January, the maintenance crew, in addition to their regular work:

- Removed Mylar balloon from Oak tree at 1821
 Parkwood Drive
- Trimmed low Oak tree branches on Parkwood Drive along sidewalks
- Removed dead Pine tree at 3413 Chris Lane in common area
- 1529 DeAnza repaired leaking mainline for irrigation system
- Installed rock as splash block for drains on Cherrywood slope at the end of Chris lane.

In February, in addition to regular work, the crew will:

- Clean sidewalk on Cherrywood
- Monitor storm drains for debris
- Repair leaking irrigation mainline near 1858 Parkwood Drive
- Mow ivy at Parkwood and De Anza (at the sign), Parkwood and Sugarloaf, and near 1404 De Anza.
 - This mowing will get rid of old and dead ivy and stimulate new growth.

LAURELWOOD PARK RENOVATION

The City of San Mateo's Parks and Recreation Department has advertised for bid the initial phase of construction work for Laurelwood Park based on the approved Laurelwood Park & Sugarloaf Mountain Open Space Management Plan, which was adopted by the City Council in 2007. The initial phase of work includes a new re-located playground area, a new restroom building and miscellaneous picnic and pathway improvements. The bids are due later this month and the construction work is estimated at \$1,500,000. No general fund resources are being used for this project.

The project is expected to begin this spring and should be completed by summer of 2011. During the construction period, the construction area will be fenced for the safety of the public and for the protection of the contractor's equipment and work site. Public access through the park will only be allowed during non-working hours and may be restricted during certain periods depending upon construction operations. The City would greatly appreciate the neighborhood's involvement in keeping a watchful eye on the park when construction work is not taking place and report any incidents of vandalism or suspicious trespass into the contractor's work site to the Police Department.

VISITOR PARKING

Please be reminded that, per Section 5.04 of our Declaration, all parking spaces (other than home driveways) on our private lanes are designated as guest parking. Owners or tenants shall not park in these spaces on a regular basis, including consistent overnight parking.

This may be quicker than dialing 911 since 911 calls are often routed to CHP due to our close proximity to Highway 92. Better safe than sorry.
