ARCHITECTURAL COMMITTEE

Annual Exterior Audit – The committee recently completed the annual exterior audit, per CC&Rs Article 4.02(b), looking for homes that are in need of landscaping work, painting work, or other exterior attention to help in keeping property values as high as possible in Sugarloaf. Owners whose home has an issue will be notified in writing by PML in the coming weeks, with specific timelines required for remediation. Thank you in advance for your cooperation in this regard.

In response to requests from homeowners, the committee is looking into the use of **paver stones** for updating driveways.

Because this would be very new for the HOA, guidelines are being developed to ensure such renovation would be done in a manner that would not negatively impact the neighborhood appearance.

LANDSCAPE

In addition to standard activities, the following work was or will be performed in common / easement areas during June/July:

 Annual brush clearing (weed abatement) in the common/easement areas – big job!

We request that homeowners trim their bushes and trees that hang over the sidewalks, so walkers don't have to avoid them.

Oak moths

We are experiencing a large infestation this year. The larvae of the oak moth can cause visible damage to the oak trees. They are striped black and yellow and at full size are 1 inch long. The adult moth, which may be tan or gray, has a 1 inch wingspan and noticeable veining on its wings. There are two generation per year. Adult moths lay their tiny eggs in groups of two or three dozen on oak leaves in May and June and in October or November. After hatching, the larvae mature into caterpillars. How do we handle this infestation? I asked an arborist, and he said that, in a small area, spraying with a selective pesticide could be effective when the caterpillars are at their early stage. Power washing of the egg masses may also be effective. We have over 20 acres of common/easement land, so neither method would be affordable or practical for 20 acres. But, it could work for a homeowner's two or three trees. The flying moths normally have a life cycle of about three weeks, if the birds don't get them first. Defoliation of an oak in one year is acceptable; the tree will recover. Consecutive years would be more of a problem. We will continue to monitor this situation and consult arborists.

Finally, please do not trim/cut any trees in common areas. Branches from common area trees that overhang a homeowner's yard are not trimmed by the HOA unless they present a fire hazard. If you want to trim for view (at your cost), or have a concern, call PML or talk to a Board member. We have a process to follow. The first step is for you to identify the work you would like done. The HOA has a list of approved arborists/firms that can perform work on HOA trees. You would submit a quotation from one of these approved firms to the HOA for board approval before any work is performed. Thanks for your cooperation.

TRASH / RECYCLING - PLEASE FOLLOW CC&Rs & CITY LAWS

Please remember that, per CC&Rs Section 5.08 (and per SM City Code!), your trash and recycling bins need to be kept out of sight, except on pickup day or the day prior. They may not be stored anywhere in sight from a street, neighboring lot, or common area. Let's all help keep the neighborhood looking nice.
